



## PUBLIC POLICY

The recently-signed **Ledbetter Law** will be applied to a tenure discrimination suit. A female professor is suing Jackson State University in Mississippi for sex discrimination under the new time limits established by the Lilly Ledbetter Fair Pay Act. According to court documents, male professors had been given tenure and promotions without being published, but LaVerne Gentry, who was reviewed for tenure in 2006 after working for the University since 1994, was denied on those grounds. While the facts of the case have yet to be evaluated by the US District Court, the Ledbetter law, which extended the time allowed for plaintiffs to file suit from 180 days after the first discriminatory paycheck to 180 days after any such paycheck is received, will allow Gentry's suit, not filed until 2007, to be evaluated based on its merit rather than the date it was filed.

The **Healthy Families Act** was introduced to both chambers of Congress in May. The bills would mandate that all employers with 15 or more employees allow a minimum of seven paid sick days for full-time employees and a prorated number for part-time workers. The leave could be used for the medical needs of employees or their families, increasing the ability of working women to attend to their medical needs and the needs of their families without facing termination. While the act has been introduced in previous sessions, it has a new provision allowing leave to be used to recover from or seek help for domestic violence or sexual assault related trauma.

AAUW strongly supports congressional efforts to keep workers and their families healthy and employed. Please urge your senators to support working women through the Healthy Families Act.

## Dr. ASHA BAJAJ PHYSICAL THERAPIST

Prior to beginning her doctorate studies in 2005, Asha Bajaj owned and operated a successful physical therapy practice near John Muir Hospital in Walnut Creek. She sold her practice in 2004 to return to India and help her ailing father. Once he was stabilized, she volunteered with Health Volunteers Overseas in Bhutan. The four-month assignment involved teaching physical therapy students and serving as a clinical resource specialist in their hospital clinics. It was a very simple lifestyle in a country that believes in measuring progress not from the “gross national product” but from the “gross national happiness.”

Upon her return in February 2005, Asha was accepted at Boston University to begin a doctorate program in physical therapy. The online courses she started in 2006 gave her the flexibility she needed at this stage of her life. Her first two semesters were humbling because of the level of technology required with the online format! One challenge was doing group assignments that required flexibility and collaboration with the online team!

Asha's target date for graduation was 2008, but as she puts it with “interruptions of two weddings and a funeral along with nursing her mother with a hip replacement” and a home remodel, she graduated in May, 2009. Her doctoral project topic was entitled *Osteoporosis and Bone Health: An Educational and Health Promotion Program*.

Asha will continue her involvement in community projects but feels that at this stage of her life, for the first time, there is no need to have a defined plan. She will explore consulting opportunities in the health promotion area and continue to work with patients.

Asha is a past president of our branch and has served in many capacities. I am sure that AAUW will be the beneficiary of her expertise. We are all so proud of her and wish her the best. Congratulations Asha!


