

The 2009 AAUW Garden Tour is almost here! Enjoy two days of garden viewing pleasure Friday, May 8, and Saturday, May 9, from 10:00 A.M. to 4:00 P.M. each day.

On the west side of Danville you will enjoy a "Hillside Garden" with two streams and thirteen waterfalls. The "California Working Garden" features 450 grapevines, an extensive fruit orchard, vegetable beds and lavender plants. And the "Mediterranean Villa" is surrounded by hundreds of oak trees with a grand view of Mt. Diablo.

On the east side of Alamo you will experience a "Serene Haven" of interwoven landscape and hardscape; it is tidy, elegant, manicured and yet relaxed and welcoming. The "Rocks in the Redwoods" opens onto a view of a pool with a luxuriant waterfall. And, surprise, there is a slice of tropical splendor lurking behind the "Alamo Jungle" garden.

Horses graze in pastures on surrounding hillsides of the "Park-Like Country Garden" on the east side of Danville. The owners use their garden to produce much of their own fruit and vegetables. And, see a "Colorful Woodland" in north Alamo with a mix of plants of highly vibrant texture and hue.

Tell everyone you know about this opportunity to view eight exceptional gardens in Alamo and Danville. Tickets are only \$30 if postmarked by Saturday, May 2; they are \$35 thereafter. Tickets for seniors aged 65+ are \$25 throughout the tour. 

NOTICE FROM THE AAUW CA PUBLIC POLICY COMMITTEE MARCH 30, 2009

Regarding the May 19, 2009, California Special Election. The State of California just dealt with a deficit of \$40 billion.

The American Association of University Women (AAUW) has been a staunch supporter of education and public health measures for 126 years. **Our nearly 14,000 members in California sympathize with those who protest proposed cuts.** The budget reductions spared few, if any, departments, programs or services. At the same time the budget also depends on significant tax increases.

The March 2008 AAUW CA statement regarding the budget deficit battle urged "a balanced approach of revenue increase and expenditure reduction geared to maintaining a safety net of vital government services". We wanted to:

- Protect the basic education and human services infrastructure.
- Maintain all health and safety standards.
- Equitably distribute funding cuts.
- Seriously assess the options for tax and fee increases.

We believe the budget proposals are the best we can expect in this difficult time. AAUW members are asked to take a deep breath and vote yes for the budget items 1-A, 1-B, 1-C, 1-D, 1-E, and 1-F on the May 19 special election ballot. To read the ballot measures, go to www.sos.ca.gov and click on ballot measures.

HIKING GROUP

On May 30 the hiking group will hike to Inspiration Point in Tilden Park. We will meet at the Sycamore Park and Ride @ 8:30 for carpooling. Bring water, trail snack and \$ for carpool driver. 
PUBLIC POLICY

The Obama administration announced guidelines for government sponsored embryonic stem cell research but would limit federal funding of work on human embryos donated at fertility clinics. Guidelines issued by the National Institutes of Health create opportunities for an expansion of research but forbid scientists to create human embryos for research or the pursuit of cloning techniques. **The new regulations are the result of President Obama's lifting restrictions that had limited federal research to a few embryonic stem cell lines.** New money will pay for hundreds of such stem cell lines that had been unavailable for the past eight years. Researchers have praised the potential of embryonic stem cells in treating illnesses because of their ability to morph into any tissue in the body. Such stem cells could potentially lead to treatments for spinal cord injuries, Diabetes and Parkinson's disease. What is not clear from research so far is whether adult stem cells will ever have the same transformative capabilities as the embryonic cells. The guidelines also detail how scientists must secure written permission from embryo donors because donation is only permitted if made voluntarily, and without compensation.

The Associated Press announced that the Michigan High School Athletic Association agreed to pay the Group Communities for Equity up to \$6 million in legal fees after the latter won a landmark case for girls' sports calendars in the state. The case began in 1998 when parents filed a lawsuit arguing girls' unusual sports schedule violated state and federal law. In 2001, a US district court judge ruled MSSHA practice discriminated against girls in violation of Title IX, the 14th Amendment to the Constitution, and a Michigan civil rights act because the girls' season was two to three weeks shorter than those of girls everywhere else in the country, and of boys' seasons. AAUW supports gender equality compliance in public school athletic programs. Title IX's impact on women's sports is one of the country's greatest success stories.

Once again, please urge your senators to support the Paycheck Fairness Act (S 182), a much needed update of the 45- year-old Equal Pay Act. This will be a perfect complement to the Lilly Ledbetter Fair Pay Act signed into law this year.
