PUBLIC POLICY

PUBLIC POLICY

We are facing another extremely important election next month where California will elect new leaders. Even though AAUW CA is not supporting any propositions this election, and therefore branches may not take positions, we are interested in these issues. Members have been following pros and cons in the propositions, and reading the positions of the candidates running for the offices of governor, senator and legislator. Their views appear in the daily news and opinion sections, and soon voter handbooks will provide more information. The League of Women Voters also provides information to the public.

AAUW is known for its keen interest in education at all levels, preschool through graduate school. In her latest message, Sue Miller, AAUW CA Vice President and Public Policy Director, has suggested that EdSource has valuable information about this on its website. EdSource is independent, nonpartisan, and a not-for-profit organization whose mission is to explain complex education issues, and suggest policy decisions to improve public schools. It compares the positions of Jerry Brown and Meg Whitman on education issues. Look at this information at http://www.edsource.org/sys_election_platforms.html. Also find information about the non-partisan candidates for Superintendent of Public Instruction.

AAUW CA is studying the California Budget Process and seeking solutions for improvement. The final AAUW CA report, to be approved by the Board, will be sent to the new governor and state legislative leaders. You can find the study outline at our website at www.aauw-ca.org/. The California Budget Process is extremely dysfunctional, and needs major work to improve it. As we know, this is the longest span of time we have been without an agreed upon budget.

We will soon receive the fall issue of the state publication Perspective. This will cover much of what is happening in AAUW statewide. The Every Member Survey that gives each member an opportunity to vote on Public Policy Priorities that will guide decisions about public policy for the period of 2011-13 will be coming soon. The survey can either be done online at [AAUW - Public Policy](#), or by mailing a hard copy to the state office.

The news from Washington DC is that The Paycheck Fairness Act has been placed on the Senate Calendar. Senator Harry Reid reintroduced the act (S 3772) and put it on the legislative calendar in an attempt to overcome potential procedural roadblocks. It is intended to give women the tools they need to obtain equal pay for equal work. If you haven't done so, please call the offices of your senators, and tell them to ask the senators to vote for this vital and necessary bill.

Did you know that women earned more doctorates than men in the United States in 2008-09? AAUW Director of Research Catherine

Hill was quoted on the front page of the Washington Post highlighting this first ever news! Despite gains across academe, women still face systemic disparities in wages. As our economy continues to struggle, and more women assume the role of breadwinner, families need this money more than ever. ❖

LUISA F. HANSEN

I first met Luisa Hansen when she was President-Elect of the Walnut Creek Branch of AAUW and I was Program Vice-President in 1988. Now that our branches have merged, I am pleased to learn more about her and find she is just as enthusiastic as before.

Luisa was born in Santiago, Chile to a family of professionals. Her father, originally from Spain, was a professor of music, and her mother was a school principal. One brother is a lawyer and one is a doctor. She received her Bachelor of Science in math with a minor in physics from the *Universidad de Chile en Santiago*. Luisa became an assistant professor there where she met her future husband from Wisconsin, William Hansen. A year after their marriage they moved to the U.S. to do their graduate work at UC Berkeley. Luisa received her Ph.D. in experimental Nuclear Physics and her husband pursued a career in engineering at the Berkeley Lawrence Laboratory where he continues to work in Material Science research even after retirement.

Most companies weren't hiring women, but Luisa was fortunate to be hired by the Lawrence Radiation Laboratory in 1959, which was convenient since they lived in Alamo and had a young son. Luisa was one of the only women scientists hired in the 1950's. She says, "Men found it difficult to relate to women. I was the only female physicist." In the late 1960's, minorities and more women started to be hired. Luisa has worked to bring more young women into scientific and engineering fields.

Luisa is proud of her son, George, a computer scientist in the Silicon Valley. He and his wife Debbie live in Danville. She is also proud of her many achievements in science. During the first 30 years of her career, she concentrated in unclassified work, enabling her to publish 170 papers. She was invited to visit labs in France, Germany, England, Russia, China and Japan, has worked with top researchers, and has been recognized by many professional organizations. In the field of Defense Technology, she worked on issues related to the dismantling of nuclear weapons after the treaty between the U.S. and Russia in the 1960's to reduce their arsenal of weapons.

In 1989, Luisa was selected Fellow of the American Nuclear Society. She's been recognized for "development of the Pulsed Sphere Program in the measurements of Neutron Cross sections for defense programs and for fission, fusion, and radiation shielding efforts in the U.S. and worldwide." She is most proud of that honor, as only 1% of members are chosen as Fellows by their peers. In 1998, she was chosen one of 50 top minority women in Science, Engineering and Technology in the U.S. by the National Technical Association.

As a member of the committee of the Status of Women, Luisa has helped women increase their interest in science and engineering. She has chaired the Scholarship Committees of the Pan American Round Table of Contra Costa and Alameda Counties and *Centro Chileno Lautaro* of San Francisco, giving support to college and university Hispanic students.

Luisa was president of Walnut Creek Branch AAUW in 1988-89, has been involved in Expanding Your Horizons in Math and Science for many years, and this year, she is Tech Trek Co-Chair of our Danville-Alamo Branch.

In 1992, Luisa was president of the Lawrence Livermore Laboratory Women's Association (LLLWA) in which she set a record for recruiting the most members. In 1989, she endorsed pay equity for women and worked on a salary study report, which resulted in a significant increase in women's salaries. LLLWA awarded a scholarship in her name.

Luisa officially retired in 1996, but doesn't relate to the word 'retirement.' In 1997, she continued to do research as a participating guest and since 1999 as a lab associate. She joyfully continues to work everyday in support of Defense Technologies Engineering and NIF. She has served over 50 years in her scientific career, because that is what she loves most to do. We are so fortunate to have Luisa Hansen as a member of our Danville-Alamo Branch AAUW. She continues to follow her own advice to those in science careers, "Be assertive, work very hard and enjoy it because it is not just a job." ❖

ART & GARDEN - October 14

On Thursday, October 14, we have an 11:00 A.M. docent tour of **Frank Lloyd Wright's Hanna House** near the Stanford campus in Palo Alto, CA. This house, also known as the Honeycomb House, isn't just another Frank Lloyd Wright design. Built in 1937, it occupies a pivotal place in the career of a man whose roughly 450 buildings helped define architecture as we know it. It is one of 17 Wright works selected by the American Institute of Architects as his most treasured gems. At Hanna House, right turned to the hexagon, the shape of honeycombs, which he found more conducive to human movement than the square. He designed an open floor plan of interlocking hexagons – there are no 90-degree walls in the entire house – and the pattern appeared in floors, tiles, and furnishings. This 3,750 square foot house of simple, straightforward materials was Wright's first non-rectangular design that actually got built. This house inaugurated the last phase of Wright's career, when shapes like circles, hexagons, and triangles dominate his work, culminating in New York's spiral wonder, the Guggenheim Museum.


