PUBLIC POLICY

In the California November 2nd election, voters have a variety of measures to consider. Proposition 19 would legalize marijuana and allow it to be regulated and taxed. Proposition 20 would place the responsibility of redistricting congressional districts in the hands of a 14 member commission of 5 Democrats, 5 Republicans and 4 people registered differently. Proposition 21 would provide an \$18 auto license fee for most vehicles which would help fund state parks. Those who paid this fee would get free admission into all state parks. Proposition 22 would prohibit the state from taking money from dedicated funds and putting them into the general fund. Proposition 23 would suspend California's anti-global warming restrictions until unemployment drops below 5.5% of four consecutive quarters. Proposition 24 would allow multistate businesses to use a sales based income calculation rather than a combination of property, payroll and sales based income calculation. Proposition 25 would end the 2/3 supermajority requirement for the state legislature to pass the budget. It would require the 2/3 majority for raising taxes however. Proposition 26 would require the state legislature to pass all new taxes by a 2/3 super majority. It also requires a vote on all local taxes and fees. Proposition 27 would eliminate the 14 member panel that will be charged with redrawing the lines of the state legislature and state board of equalization. Proposition 18, which would have provided for an \$11.1 billion bond measure to update the water supply and transmission system in California has had so many opponents that it has been removed from ballot listing and will have to roll over onto the next governor's desk for revision.

State government employment has risen by 16% since 1995. Pension obligations for public workers are threatening to drive the state budget into disaster. A possible changeover in the U.S. Congress might signal a denial to bail out state governments who cannot curb budget expenses like California's. Mighty entitlements, which have made a better life for its citizens, are also threatening California's budget. After all, other states that have tightened their belts and curbed expenditures will show no mercy to California in the future.

Federal judge Vaughn Walker in his ruling has allowed same sex couples to marry in California beginning August 18. This isn't the end; it is just the beginning of initiating more appeals to block these marriages, going all the way to the U.S. Supreme Court, if it wishes to hear the case. The opponents of Walker's ruling, the defendant interveners, who have already filed papers, will have to show real harm to traditional marriage to gain any standing with the 9th Circuit Court of Appeals. As of this writing, no other groups have joined the proponents to block same sex marriages in the next round of court hearings. AAUW warned us in the beginning that with the passage of Proposition 8, when one group of our citizens is denied equal protection under the law, we all suffer. In changing the wording of the California Constitution to deny protection to any of our citizens, we did just that. Now, the next phase of this drama has just been announced. Same sex marriage has been placed on indefinite hold as judges and litigants go about the next legal steps.

Governor Schwarzenegger has nominated Tani Cantil-Sakauye, an appellate court justice to be chief justice of the California Supreme Court. She is a former prosecutor and Sacramento Superior Court judge and would replace Chief Justice Ronald George, who has announced he will retire January 2, 2011. Cantil-Sakauye has been on the 3rd District Court of Appeals since 2005. If she is approved by a three-member commission and by voters in November, she would begin a 12-year term.

LAF UPDATE

We are very proud to announce that on July 30, we received a letter from the national AAUW organization congratulating our branch for its outstanding achievement in fundraising. The AAUW Danville-Alamo Branch achieved FIRST PLACE among the Top Ten Researchers to provide understanding of issues that are important to women and girls through **Total Branch Giving to the Eleanor Roosevelt Funds**. This is a wonderful accomplishment for women and girls through advocacy, education, philanthropy, and research. Top Ten Branch and State Fundraising awards are among AAUW's highest branch and state honors. The letter went on to say that it is only through this ongoing support and commitment of its members and donors that AAUW can continue to be a leading champion for women and girls.

Again, a very special thank you to each of you who contributed to LAF fundraisers this past year.

Action Updates

Case Conclusion: LAF-supported plaintiff Claire Schuster's pay discrimination case against Berea College (KY) has concluded in an undisclosed settlement. AAUW disbursed more than \$60,000 to Schuster over four years, and she spoke at several state conventions and at the 2007 national convention. Schuster has always been very appreciative of AAUW members' support and said that sometimes it was the only thing that helped her through the day.

Amicus Brief: AAUW signed an amicus brief for the recently decided U. S. Supreme Court case Christian Legal Society v. Martinez. The court had to decide whether or not the University of California Hastings College of Law could deny school funding to a religious student organization because the group bans gays and lesbians. AAUW supported the university's policy of denying funds to the group. In a 5 to 4 decision, the Supreme Court found that the law school's policy was a reasonable, viewpoint-neutral condition on access that did not raise First Amendment issues in the way that the Christian Legal Society argued.


